

## PURDUE UNIVERSITY COLLEGE OF PHARMACY Department of Pharmacy Practice Faculty and Staff, academic year 2022-2023

EPHREM ABEBE, BSPharm, MPharm, MS, PhD is an Assistant Professor. Ephrem received a BS in Pharmacy from Addis Ababa University School of Pharmacy in Ethiopia, MS in Clinical Pharmacy from the National Institute of Pharmaceutical Education and Research in India, and MS and PhD in pharmaceutical health services research (formerly social and administrative pharmacy) from the University of Wisconsin-Madison School of Pharmacy. He also completed a postdoctoral research fellowship focused on healthcare transitions, patient safety, and human factors engineering and system design at the Armstrong Institute for Patient Safety and Quality in The Johns Hopkins University School of Medicine. He leads a highly interdisciplinary research program that leverages approaches from health services research, implementation science, human factors engineering, and participatory design. A core focus of Ephrem's research program is related to understanding and supporting the longitudinal medication use experience of patients and their family caregivers as they journey through the healthcare system. Some examples include developing digital tools to support discharge readiness and medication management during the hospital-to-home transition period for patients/caregivers with medical and social complexity. Between 2020-2022, Ephrem was a KL2 scholar with the Indiana Clinical and Translational Sciences Institute (CTSI). His research is funded through grants from Indiana CTSI and the National Institutes of Health.

JEROME ADAMS, MD, MPH, FASA is a Distinguished Professor, an appointed Presidential Fellow, and the Executive Director of Purdue's Health Equity Initiatives. As the 20th U.S. Surgeon General and a prior member of the President's Coronavirus task force, Jerome has been at the forefront of America's most pressing health challenges. A regular communicator via tv, radio, and in print, he is an expert not just in the science, but also in communicating the science to the lay public, and making it relevant to various audiences. He is a licensed anesthesiologist with a master's degree in public health, and ran the Indiana State Department of Health prior to becoming Surgeon General. In the State Health Commissioner role, he managed a \$350 million budget and over 1,000 employees, and led Indiana's response to Ebola, Zika, and HIV crises. Notably, Jerome helped convince the Governor and State Legislature to legalize syringe service programs in the state and to prioritize \$13 million in funding to combat infant mortality. As Surgeon General, he was the operational head of the 6,000-person Public Health Service Commissioned Corps, and oversaw responses to 3 back-to-back category 5 hurricanes, and to a once-in-a-century pandemic. In addition to his recent COVID-19 work, Jerome has partnered with and assisted organizations as they navigate the opioid epidemic, maternal health, rising rates of chronic disease, the impacts of rising suicide rates in our Nation, and how businesses can become better stewards and stakeholders in promoting community health. Jerome joined the faculty in 2021.

OMOLOLA (LOLA) ADEOYE-OLATUNDE, PharmD, MS, is an Assistant Professor. She is the founder and director of HER (health equity research) Lab, an innovative community-engaged research "collaboratory" focused on reducing health disparities and advancing health equity. She serves as the Community Engagement and Evaluation Director for the Center for Health Equity and Innovation (CHEqI) and Co-Director of the Community Health Workforce Development Institute (CHWDI). Lola's research investigates drivers of effective and equitable implementation and provision of community-based programs among populations disproportionately affected by health inequities. She works alongside communities and community-based organizations nationally and globally to co-create and evaluate approaches focused on addressing inequities in under-resourced communities by meeting them right where they are. Lola's award-winning work in this space has been recognized locally and nationally, including the Bowl of Hygeia Award for her outstanding record of civic leadership in the communities she serves, selection as an NIH-National Institute on Minority Health and Health Disparities (NIMHD) Health Disparities Research Institute Scholar, named a Purdue University Societal Impact Fellow for her demonstrated societal impact in the real world beyond academia, recipient of the 2022 AcademyHealth Alice S. Hersh Emerging Leader Award, and recognized as a Top 40 Under 40 Minority Health Leader by the National Minority Quality Forum (NMQF). Lola earned her BS in Biology from Morgan

State University in 2013, PharmD from MCPHS University in 2016 before completing a PGY1 community-based residency at Kroger Pharmacy, followed by an MS in Health Services, Outcomes, and Policy and a Community Practice Research Fellowship at Purdue University in 2020. Lola joined the faculty in 2020.

CHELSEA M. BAKER, PharmD, MBA is a Clinical Assistant Professor and a Clinical Pharmacist at the Center for Healthy Living. She received her PharmD degree from Purdue University and completed a Health-System Pharmacy Administration Residency at Johns Hopkins Hospital in Baltimore, Maryland. Chelsea has also received her MBA in Medical Services Management from the Johns Hopkins Carey Business School. Her practice site is the Center for Healthy Living in West Lafayette, where she initiated a collaborative practice agreement to manage diabetes, hypertension, dyslipidemia, and other primary care issues for Purdue employees and their dependents. She serves as the Associate Director of the Professional Program Laboratories. She is a member of the Assessment and Experiential Learning and Advisory Committees at Purdue University, College of Pharmacy and has held various leadership roles in state and national pharmacy organizations. Her teaching and research interests include medication safety, outpatient and ambulatory care pharmacy, and teaching and learning methodologies. Chelsea has been employed at the College of Pharmacy since 2015 and joined the faculty in 2018.

**NOLL L. CAMPBELL,** PharmD, is an Associate Professor. He received his PharmD degree from Butler University, completed a pharmacy practice residency at St. Vincent Hospital in Indianapolis, then a geriatric pharmacotherapy residency at the University of North Carolina in Chapel Hill, NC. As an investigator with the Indiana University Center for Aging Research and the Regenstrief Institute, Inc., his research focuses on optimizing medication regimens to preserve brain health. Specifically, he has published articles identifying medications with anticholinergic properties and described the impact on long term cognitive impairment. Noll has also conducted work either as primary or coinvestigator in the fields of medication adherence, delirium, and implementation science. His research has been funded by the National Institute of Health, Agency for Healthcare Research and Quality and the pharmaceutical industry. He has been active in the Indiana Pharmacists Alliance, Indiana Academy of Senior Care Pharmacists, Indiana chapter of the American College of Clinical Pharmacy, the Indiana Geriatrics Society, the American Geriatrics Society, and the American Delirium Society. In 2008, he was selected as a Fellow of the American Society of Consultant Pharmacists, in 2012 he was the first PharmD recipient of the Merck/American Geriatrics Society New Investigator Award, and in 2014 he was the first PharmD invited to the Charleston Conference on Alzheimer's disease. He has been awarded the Tony and Mary Hulman Award in Geriatrics from the Indiana Public Health Foundation, and in 2023 will serve as the President of the American Delirium Society. Noll joined the faculty in 2016.

**FARIA A. CHAUDHRY,** PharmD, BCPS, BCACP is a Clinical Assistant Professor. She received a B.S degree in Biochemistry from Middle TN State University and a PharmD degree from the University of TN Health Science Center. She completed her PGY1 Residency and PGY2 Ambulatory Care Residency at Saint Joseph Health System in Mishawaka, Indiana. Her teaching topics involve chronic care disease states. Faria's research interests include implementation science, developing programs and tools that improve patient outcomes or the social determinants of health. She has currently been involved with the development of practice sites in order to provide pharmacy services to health clinics. Faria joined the faculty in 2022.

JUDY T. CHEN, PharmD, BCPS, BCACP, CDCES, FNAP is a Clinical Associate Professor. She received her PharmD degree from the University of Illinois at Chicago and completed a PGY1 Pharmacy Practice residency at University of California San Francisco and a PGY2 Primary Care Specialty Residency at the National Institutes of Health. Judy's teaching interests are in therapeutics of women's health and chronic disease management. Her initial practice area started with chronic disease management for underserved patients. She has experience establishing both Medication Therapy Management Service (Pharmacotherapy Referral Service) and Collaborative Drug Therapy Management Service to reduce cardiovascular risk reduction for patients at Federally Qualified Health Centers. In 2022, her clinical practice site transitioned to Women's Health Center at Community Health Network in Indianapolis, Indiana where her focus has shifted to the ambulatory setting primarily working with women to reduce their cardiovascular risks, assist

with management of hypertensive disorders of pregnancy, hyperemesis, and other common disorders related to women's health. Her clinical practice, teaching, and research interests predominantly focus on developing pharmacist-managed services, patient education, women's health, preventative care, and care for the underserved. In addition to precepting PharmD experiential students, she is also a co-coordinator for PHRM 825 (Integrated Pharmacotherapy I). She is a recipient of the Purdue Teaching for Tomorrow Award and a recipient of the Community of Service-Learning Faculty Fellow program through the Center for Instructional Excellence. She is also a Fellow of the National Academy of Practice of Pharmacy within the National Academies of Practice. Currently, she the first and only pharmacist who serves on the Advisory Council for the HER foundation, the leading not-for-profit organization for Hyperemesis Gravidarum. Judy joined the faculty in 2003.

**AMANDA CORREA** is a lead administrative assistant with the Pharmacy Practice Department. In her role, she focuses on meeting the administrative needs of the Department Head and Indianapolis-based faculty. She is the Indianapolis staff lead for the Pharmacy Practice Social Committee. She is a graduate of Michigan State University and holds a bachelor's degree. Amanda joined the Department of Pharmacy Practice in 2019.

PATRICIA L. DARBISHIRE, PharmD is a Clinical Professor and the Associate Dean for the College of Pharmacy at Purdue University. She earned an Associate's degree in journalism, a BS degree in biology with a minor in Chemistry from Illinois State University and her PharmD degree from Purdue University. She has extensive community pharmacy and disease state management experience, including certification training in immunizations, Medicare and disability training, First Responder, diabetes and pharmaceutical care. Her research and practice include establishment of community-based partnerships, service-learning, interdisciplinary initiatives, medication safety and adherence in community pharmacy practice, and substance use disorder and treatments. Using innovative course design and instructional methods, she created the 10 credit-hour introductory pharmacy practice experience program - spanning 3 years of the curriculum. Patti also established several advanced clinical rotations in the areas of ambulatory care, hospice care, medication assistance programs, Medicare and academic/research-based rotations. In addition to her selection as a fellow in the Big Ten Academic Alliance Leadership Program, she was recognized with a Purdue Teaching for Tomorrow Faculty Fellowship Award for long-term contributions to teaching, mentoring, and improving the learning environment for students and faculty. She served as Chair of the American Association of Colleges of Pharmacy Experiential Education section and completed two terms on the American Journal of Pharmaceutical Education editorial board. She is the former Editor-in-Chief of the Purdue Journal of Service-Learning and International Engagement, and a long-term faculty fellow and mentor with the Purdue Center for Instructional Excellence and the Community of Service Learning Faculty Fellows. She provided expertise to the Indiana Attorney General's Prescription Drug Abuse Prevention Task-Force, a member of the Purdue Engagement Advisory Board and a support mentor in the nationally acclaimed Purdue IMPACT program. As Associate Dean, Patti provides oversight of all measures of student and faculty success, learning and assessment, recruitment, admissions, career development, and 26 pharmacy student organizations. She is a College representative at national and international meetings, and regularly interfaces with University offices responsible for academic affairs and leadership. Patti joined the faculty in 2002.

DANIEL D. DEGNAN, PharmD, MS, CPPS, FASHP currently serves as the Associate Director for the Professional Program Laboratory and is a Clinical Assistant Professor of Pharmacy Practice (Courtesy). Currently, Dan teaches 3rd year pharmacy students and coordinates the PHRM 860 and PHRM 861 course series and coordinates PHRM 870 (Health Policy Applications). He is also a co-coordinator for PHRM 868 (Patient Safety and Informatics). Dan has an appointment at the Regenstrief Center for Healthcare Engineering at Purdue at the Associate level with expertise and research interests in the area of medication safety technology, advanced pharmacy automation, pharmacy operations and high reliability in healthcare. He currently works on funded research in the area of patient safety with the use of smart infusion devices. Prior to his role at Purdue, Dan served as the Medication Safety Officer at Community Health Network in Indianapolis, Indiana for almost 10 years. During his time at Community, the health system was recognized as a finalist for American Society of Health-System Pharmacists' (ASHP) award for Excellence in Medication

Use Safety and with a Cheers award from the Institute for Safe Medication Practices. Dan received his BS (Pharmacy) and PharmD degrees at Purdue University, and he completed a specialty residency in pharmacy administration and a Master's Degree in Pharmacy Administration at the University of Wisconsin. The Institute for Healthcare Improvement recognizes Dan as a Certified Professional in Patient Safety (CPPS). He has held leadership positions in national organizations for both pharmacy and healthcare quality. Dan has been employed at the College of Pharmacy since 2013.

SHARON M. ERDMAN, PharmD, FIDP is a Clinical Professor. She received her PharmD degree from the University of Illinois at Chicago College of Pharmacy, and completed a specialized residency and fellowship in the areas of Infectious Diseases and Pharmacokinetics at the University of Illinois at Chicago College of Pharmacy. Sharon's clinical practice resides at Eskenazi Health where she serves as the inpatient Infectious Diseases Clinical Pharmacist and Co-Director of the Outpatient Parenteral Antimicrobial Therapy (OPAT) Program. Her teaching interests include infectious diseases pharmacotherapy, HIV pharmacotherapy, and pharmacokinetics, and her research interests include in vitro and clinical research in the areas of infectious diseases, antibiogram development/applicability, and OPAT. Her current projects including (1) adverse effects and complications in patients receiving OPAT; (2) evaluating the epidemiology, clinical course and treatment outcomes of OPAT patients with diabetic foot infections; (3) evaluating the epidemiology, clinical course and treatment outcomes of OPAT patients with orthopedic hardware-related infections; (4) mandatory infectious diseases approval of OPAT: Clinical and economic outcomes of averted cases; and (5) clinical impact of rapid detection of bacteria from blood cultures using Biofire collected from patients in a teaching hospital. Sharon joined the faculty in 2004.

**DAVID R. FOSTER,** PharmD, FCCP is an Associate Professor. He received his BSc (Biology) degree from the University of Windsor, Windsor, Ontario, and BS (Pharmacy) and PharmD degrees from Wayne State University, Detroit, Michigan. He completed a Postdoctoral Fellowship in Critical Care Pharmacotherapy at The University of Michigan, Ann Arbor, Michigan. Dave's research is focused on using epidemiologic approaches to improve drug safety in critically ill patients and other populations, and his current research includes using health information exchanges to evaluate and improve the safety of opioids. Dave's other interests include the study of the contribution of active transport processes to variability in drug disposition in a number of patient populations. His teaching and clinical interests are focused on gastroenterology and critical care (with an emphasis on burn and trauma patients). Dave joined the faculty in 2002.

JASMINE D. GONZALVO, PharmD, CDCES, BC-ADM is a Clinical Professor and the Chris and Theresa Dimos Director of the Center for Health Equity and Innovation and in the College of Pharmacy. She provides cardiovascular risk reduction medication management services for diabetes, hypertension, dyslipidemia, and tobacco use disorders at Eskenazi Health Pecar Health Center for a largely LatinX/Hispanic population in a Federally Qualified Health Center. She has served on and chaired national Boards for several diabetes organizations. She is active in advocacy efforts at the State and Federal levels, most recently having served on the National Clinical Care Commission charged with making recommendations to improve diabetes across federal programs. Her research interests relate to community health workers, cardiovascular risk reduction in disinvested populations, integration of the Spanish language into practice and academic settings, and diabetes self-management education and support in the pharmacy setting. She has received a variety of awards highlighting her excellence in practice and teaching throughout her career. Jasmine joined the faculty in 2007.

KAREN S. HUDMON, DrPH, MS, RPh, FAPhA, CTTS is a Professor. She received her BS (Pharmacy) from Ohio Northern University, MS (Pharmacy Care Systems) from Auburn University, and DrPH (behavioral science, epidemiology) from The University of Texas School of Public Health in Houston. She was a recipient of an NIH/NCI pre-doctoral fellowship award and completed a 2-year postdoctoral fellowship in Cancer Prevention at The University of Texas MD Anderson Cancer Center. Karen's research involves the treatment of tobacco use and dependence through expansion of the clinician's role in cessation. She co-coordinated an effort to develop, evaluate, and disseminate a shared

comprehensive tobacco cessation training program, *Rx for Change: Clinician-Assisted Tobacco Cessation*, for students in the health professions. She has been a recipient of more than 20 academic awards, including the AACP Dawson Award, AACP Sustained Scholarship Award, APhA Research Achievement Award, APhA Wiederholt Prize (twice), APhA Clinical Research Paper Award, Indiana Public Health Foundation Excellence in Health Science Research Award, and the Purdue University Faculty Scholar and Chaney Awards. In 2016, she received the Public Health Excellence Award from the Surgeon General's Office/US Public Health Service for her sustained contributions in the area of tobacco cessation education. For more than two decades, her research has been funded by the NIH and other non-commercial funding organizations. Currently, she is the Principal Investigator of grants from the National Cancer Institute and the Indiana State Department of Health. Karen joined the faculty in 2006.

KYLE HULTGREN, PharmD, is a Clinical Assistant Professor and is the founding director of the Purdue University College of Pharmacy's Center for Medication Safety Advancement. He received his PharmD degree from Purdue University. Kyle's current research includes extensive work on dashboards and measurement systems for the evaluation and improvement of medication use systems as well as the integration of publicly available social media data as potential surveillance signals. As a result of this work, he guided the creation of SafeRx, a large, curated, relational database containing millions of adverse drug events gathered using AI tools. He is responsible for the creation and dissemination of innovative online education programming for medical professionals targeted at expanding professional competency using non-traditional methods. In addition to his research, he has worked extensively to bring new safety concepts to medical professionals and holds three patents on medical devices designed to improve patient safety. Kyle founded a two-year post-PharmD fellowship in medication safety and regulatory affairs, a program that has now graduated 10 fellows. He lectures nationally and internationally on safe medication use practices and is the recipient of the 2015 Purdue University College of Pharmacy's Dr. Aziz Teaching Award. Kyle has been employed at the College of Pharmacy since 2008 and joined the faculty in 2022.

KIMBERLY S. ILLINGWORTH, PhD, FAPhA is a Professor as well as the Assistant Dean for Learning and Assessment at the College of Pharmacy. Kim obtained her BS in Pharmacy from Butler University and her PhD in Pharmacy Administration from Purdue University. Her teaching and research interests predominantly focus on patient care, including patient behavior change, motivational interviewing, and health literacy, as well as the evaluation of the instructional methods to teach these topics to students. She established and directs the Purdue University Academic and Ambulatory Care Fellowship program. She served as Chair of the Economic, Social, and Administrative Sciences section of the American Pharmacists Association and the American Association Colleges of Pharmacy Social and Administrative Sciences section. She currently serves as Chair of the Teaching Academy Executive Council at Purdue. Her honors include being named in the Purdue University Book of Great Teachers and as a Purdue University Teaching Academy Fellow. In addition, she received an honorable mention for two Innovations in Teaching portfolios from the American Association of Colleges of Pharmacy, the Dr. Aziz Award for Outstanding Teaching at the Purdue University College of Pharmacy, and the Purdue University Charles B. Murphy Award for Outstanding Undergraduate Teaching. Kim joined the faculty in 2003.

**ALEX N. ISAACS,** PharmD, MS, BCPS is a Clinical Associate Professor. He received his PharmD from the Butler University College of Pharmacy and Health Sciences and then completed a two-year pharmacotherapy residency at Butler University and Indiana University Health. His practice site is at Indiana University Health Arnett Hospital in Lafayette, IN as a clinical pharmacy specialist in internal medicine, where he precepts PharmD and PGY1 pharmacy residents. Alex's teaching topics include diverse acute care topics while his research interests revolve around the scholarship of teaching and learning for pharmacy students and residents. His honors include Distinguished Young Pharmacist from the Indiana Pharmacists Association, Purdue University College of Pharmacy Chaney Family Faculty Preceptor of the Year, American College of Clinical Pharmacy New Educator Award, and American Association of Colleges of Pharmacy Emerging Teaching Scholar. Alex joined the faculty in 2014.

**EMILY N. ISRAEL,** PharmD, BCPS, BCPPS is a Clinical Associate Professor. She received her Bachelor of Science from Rutgers University and earned her PharmD from the University of Iowa. She then completed a PGY1 Pharmacy Practice residency and a PGY2 Pediatric Pharmacy Specialty residency at the University of Michigan Health System in Ann Arbor, Michigan (now Michigan Medicine). Emily is a Board Certified Pharmacotherapy Specialist (BCPS) and a Board Certified Pediatric Pharmacy Specialist (BCPPS). Her practice at Riley Hospital for Children in Indianapolis, Indiana is focused on pediatric cardiology. She also serves as a clinical preceptor for PharmD students and Indiana University Health pharmacy residents; her didactic teaching is focused on pediatric pharmacotherapy. Her research interests relate to pediatric pharmacy education and medication therapy in patients with congenital heart disease. Emily joined the faculty in 2014.

HYUNYOUNG JEONG, PharmD, PhD is a Professor in the Departments of Pharmacy Practice and Industrial and Physical Pharmacy. Hyunyoung received her PharmD (2001) and PhD (2004) from the University of Illinois at Chicago (UIC), followed by postdoctoral training in molecular pharmacology at UIC. She joined the UIC faculty in 2006 and established a research program in drug metabolism and pharmacokinetics, funded by multiple extramural grants including NIH and DOD. Her current research focuses on (1) elucidating mechanism underlying altered pharmacokinetics during pregnancy, (2) defining roles of the gut microbiota in the modulation of drug efficacy and toxicity, and (3) identifying gut bacterial metabolites involved in host-gut microbiota interaction. Hyunyoung received an Early Career Achievement Award in Drug Metabolism and Disposition from the American Society of Pharmacology and Experimental Therapeutics. She currently serves on the editorial boards for *Drug Metabolism and Disposition* and *Pharmacological Reviews*. Hyunyoung joined the faculty in 2021.

**DEANNA S. KANIA**, PharmD, BCPS, BCACP is a Clinical Associate Professor and a Clinical Pharmacy Specialist in Ambulatory Care at Veteran Health Indiana – Roudebush VA Medical Center in Indianapolis, Indiana. Deanna received her PharmD from Purdue University and completed her PGY1 Pharmacy Practice and PGY2 Critical Care Residencies at the University of Kentucky Medical Center, Lexington, Kentucky. In 1997, she established the PGY1 Residency Program at Veteran Health Indiana and continues to serve as the Residency Program Director. She also started the Ambulatory Care / Education PGY2 Residency Program in 2006 and continues to serve as a coordinator and preceptor for the program. In 2009, she collaborated with pharmacy administration at the VA and developed a non-traditional pharmacy residency program. This was recognized nationally in 2010 with the VA Under Secretary of Health Pharmacy Benefits Management Innovation Award. At Purdue, Deanna teaches within the therapeutics course sequence and the professional skills labs, and she serves as a course cocoordinator for PHRM 84400. She also serves as the Pharmacy Practice Department Director for Residency/Fellowship Programs, is a member of the Admissions Committee, where she was Chair of the committee in 2022-2023, and serves on the Department of Pharmacy Practice Executive Team. At the VA, her clinical practice specialty areas include: infectious disease (with an emphasis in HIV management), endocrinology (with an emphasis in diabetes therapy), and cardiology (with an emphasis in hypertension, hyperlipidemia, and anticoagulation management). In 2012, she received the Indiana Society of Health-System Pharmacists "Glen Sperandio Hospital Pharmacist of the Year" Award. At the national level, she serves as an ASHP guest surveyor for accreditation of residency programs. Deanna joined the faculty in 1996.

**RAKHI KARWA**, PharmD, BCPS is a Clinical Associate Professor. After graduating from University of California, San Francisco School of Pharmacy, she completed two years of residency at University of North Carolina Hospitals, specializing in infectious diseases. Her areas of work include global health and health equity, and she has been a leader in the Purdue Kenya Partnership, which is a collaboration between Purdue University, Moi University, Moi Teaching and Referral Hospital and AMPATH (the Academic Model Providing Access to Healthcare). Through her work with the Purdue Kenya Partnership, she has been able to collaborate with Kenyan pharmacy leadership to create innovative clinical pharmacy training programs onsite, including a Clinical Pharmacy Internship Program, a Postgraduate Diploma in Clinical Pharmacy and a Master of Pharmacy in Clinical Pharmacy. Rakhi serves as a preceptor for Purdue University College of Pharmacy students completing their Global Health APPE with the

Purdue Kenya Partnership. In addition, she is the fellowship director for the Global Health Equity Fellowship, which works in partnership with the United States Agency for International Development. She is a faculty associate and the Academic Initiative Lead with the Center for Health Equity and Innovation, where she works to create student opportunities in health equity learning both inside and outside of the classroom setting. Rakhi joined the faculty in 2011.

**JENNIFER KAWLEWSKI** is an administrative assistant with the Pharmacy Practice Department. In her role, she focuses on meeting the administrative needs of Pharmacy Practice by providing course support for faculty and being available for various other departmental needs.
